

## Oxford – Cambridge Expressway – UPDATE 15/11/18

### What's new

- BBOWT have not formally launched a fundraising effort to support their legal challenge to the government for not following due process and completing a Strategic Environmental Assessment prior to choice of corridor for the proposed Expressway.
